## Definitions

**\*Resident for tax purposes** – a natural person whose income is subject to taxation under national laws and regulations of relevant country, e.g. if a person's place of permanent residence is in any specific state, the duration of the stay is more than 183 days and more within a 12-month period, close personal or economic relations or any other criteria serving as the basis for taxation of income in a relevant country (e.g. in the US, inter alia, a US citizen or resident who has a residence permit (Green Card), is deemed to be a US tax resident).

**\*Politically exposed person** – a natural person who is or was during the past 18 months, entrusted with prominent public functions in the Republic of Lithuania, the European Union, international or foreign state institutions as well as close members or close assistants of such person.

**Close members** – the spouse, the person with whom partnership has been registered (hereinafter referred to as the 'cohabiting partner'), parents, brothers, sisters, children and children's spouses, children's cohabitant partners.

**Close associate:**

- 1) a natural person who, together with the person who is/was entrusted with the above mentioned prominent public functions, participates in the same legal entity or maintains other business relations;
- 2) a natural person who is the only owner of the legal entity set up or operating de facto with the aim of acquiring property or another personal benefit for the person who is/was entrusted with the above mentioned prominent public functions.
